AA info back at St. Lucie Fair for third year

The Hand of AA will be extended again at the St. Lucie County Fair Friday, February 23, through Sunday, March 4.

Volunteers from across District 6 will display and offer AA literature and be available to answer questions, but won't "hawk the wares:" Attraction, Not Promotion.

"This is absolutely service as suggested by AA's Public Information service commitment," said Terry M., chair of the District Six Public Information/
Cooperation with the Professional Community (PI/CPC) Committee.

"We've had discussions at Area Quarterlies about providing AA info at health fairs and other events like these," Terry explained. "Our General Service Office has supporting literature and guidelines offered for raising pubic awareness of AA's Solution at public events without crossing the line into promotion."

The AA booth will be in the Community Building, among a number of non-profits and agencies such as the county health department and sheriff's office.

A SECOND STEP PRAYER

The Second Tradition ...

For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern.

The Second Tradition Checklist ...

- 1. Do I criticize or do I trust and support my group officers, AA committees, and office workers? Newcomers? Old-timers?
- 2. Am I absolutely trustworthy, even in secret, with AA Twelfth Step jobs or other AA responsibility?
- 3. Do I look for credit in my AA jobs? Praise for my AA ideas?
- 4. Do I have to save face in group discussion, or can I yield in good spirit to the group
- 5. Although I have been sober a few years, am I still will-ing to serve my turn at AA chores?
- 6. In group discussions, do I sound off about matters on which I have no experience and little knowledge?
