# Why did Bill W. replace the original 6 Step program with the 12 Step program?

The book *Alcoholics Anonymous Comes of Age* (AACA), authored by Bill W, provides some answers on the origins of the 12 Steps. (pages 159-162).

By early 1938 some of the fellowship felt the need for a book and the decision was made to produce one. Bill was to be the author of the book and by the fall of 1938 Bill had completed writing four chapters with the titles "Bill's Story" "There is a Solution" "More About Alcoholism" and "We Agnostics." In *Alcoholics Anonymous Comes of Age*, on page 159, Bill says:

"It was now realized that we had enough background and window-dressing material and that at this point we would have to tell how our program for recovery from alcoholism really worked. The backbone of the book would have to be fitted in right here."

On pages 160-161 of AACA, Bill describes how he wrote the 12 Steps. Bill says that on one afternoon in fall 1938:

"I lay in bed at 182 Clinton Street with pencil

in hand and with a tablet of scratch paper on my knee. I could not get my mind on the job, much less put my heart into it. But here was one of those things that had to be done.

"Slowly my mind came into some kind of focus. Since Ebby's visit to me in the fall of 1934 we had gradually evolved what we called 'the word-of-mouth program.' Most of the basic ideas had come from the Oxford Groups, Williams James, and Dr. Silkworth. Though subject to considerable variation, it all boiled down into a pretty consistent procedure which comprised six steps." (See below for the six steps.)

Bill says that, after reflecting on these developments between the fall of 1934 and the fall of 1938, he decided he wanted to write more than 6 Steps and didn't really want to document the 6 step program that the fellowship was actually using at the time.

In AACA Bill says: "Finally I started to write. I set out to draft more than six steps; how many I did not know. I relaxed and asked for guid-

helping others in need, without the usual demands for personal prestige or material gain.

6. By meditation, he sought God's direction for his life and the help to practice these principles of conduct at all

The thing about the original 6 Step 'word of mouth' program is that it varied from person to person in the early fellowship. Each of the members had a slightly different personalized version that they used. Just like Bill says in AACA, there was "considerable variation" between the versions, but it was still "a pretty consistent procedure that comprised six steps." For example, here is a version of the 6 Steps from one of Bill's taped talks:

- 1. We admitted we were licked.
- 2. We got honest with ourselves.
- 3. We got honest with someone else.
- 4. We made amends for the harm we'd done.
- 5. We tried to help others with no thought of return.
- 6. We prayed to whatever God we thought there was for the power to take these actions.

Probably the most compelling reason Bill decided to expand on the six steps? Bill says on pages 162-164 of AACA that, in 1938-1939, when the 12 Step program of the Big Book was being written, there were three "camps of drunks". Bill describes them as:

Conservatives: "Akronites like Paul and Dick S. liked the new steps very much....Fritz M., the Episcopal minister's son from Maryland and the second man to recover at Towns Hospital, Radicals: "They wanted the word 'God' made constant journeys to New York in deleted from the book entirely.....What order to reinforce the conservative position. Fitz thought that the book ought to be Christian in the doctrinal sense of the word and that it should say well. Bill never specifies exactly who so. He was in favor of using Biblical terms and expression to make this clear. Another New York A.A., Paul K., was even more emphatic about this."

Liberals: "The liberals were the largest contingent and they had no objection to the use of the word 'God' throughout the book, but they were dead set against any other theological proposition. They would have nothing to do with doctrinal issues."

Henry, Jimmy, and company wanted was a psychological book." Henry was Hank Parkhurst. Jimmy was Jim Burhe meant by "and company" but it likely included Ray Wood and Howard

The ultimate salesman, and diplomat, Bill was able to navigate the three prevailing "Camps of Drunks" and provide a series of steps that could be agreed upon by all. History is still being played out in the lives of all of us who are currently following this path.

ance. With a speed that was astonishing, considering my jangling emotions, I completed the first draft. It took perhaps half an hour."

Bill seems to be claiming that it was divine inspiration (i.e. "guidance" in the Oxford Groups practices of the time was listening for God's voice) that led him to write the 12 Step program.

Bill says: "When I reached a stopping point, I numbered the new steps. They added up to twelve. Somehow this

St. Lucie Intergroup Association, Inc. 883 E Prima Vista Blvd., Port St Lucie, Fl 34952 number seemed significant. Without any special rhyme or reason I connected them with the twelve apostles."

Surprise, surprise. 12 steps, 12 apostles. I think a point can be made that Bill was intentionally looking for the religious symbolism of the number 12 when he decided on writing a new 12 Step program, instead of documenting the original 6 Step program that the two fellowship groups in New York and Akron were actually using between 1934 and 1939.

Bill intentionally cultivated and promoted the idea that the 12 Steps were divinely inspired by God's "guidance" to Bill on that fall day in 1938.

Another factor at play in the time period of 1938 and 1939 is that the early members did not understand alcoholism (addiction to alcohol) and what was really keeping them sober.

Jim Burwell wrote: "You see the real idea was that all you had to have was a spiritual experience. Get down on your knees, understand your problem, and no more booze. We had no more idea in the world, I give you my word on

this, in '38, that the reason we were staying sober was that we were holding on to each other ... We began to see that only those going to meetings were staying sober." (James Burwell, AA pioneer, author of "The Vicious Cycle" Alcoholics Anonymous -- Second Edition).

Ebby T. was Bill W.'s sponsor. Ebby applied a version of the six steps to his own life and transmitted them to Bill in 1934. In the pamphlet Three Talks to Medical Societies, Bill describes the 6 Step program Ebby Thatcher used:

- 1. Ebby admitted that he was powerless to manage his own life.
- 2. He became honest with himself as never before; made an 'examination of conscience.'
- 3. He made a rigorous confession of his personal defects and thus quit living alone with his problems.
- 4. He surveyed his distorted relations with other people, visiting them to make what amends he could.
- 5. He resolved to devote himself to (Continued on page 7)

- 3. Do I look for credit in my AA jobs? Praise for my AA ideas?

- 5. Although I have been sober a few years, am I still will-ing to serve my turn at AA chores?
- 6. In group discussions, do I sound off about matters on which I have no experience and little knowledge?
